The prescribed amount is to be deposited through NEFT / Bank Challan (copy attached). The details for NEFT/Online Mode are noted below: -



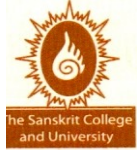
